#### CONSTRUCTION OF CANAL DEVELOPMENT PROJECT AT INDUSTRIAL ESTATE AT RATMALANA

1. The Chairman, Ministry Procurement Committee on behalf of the Secretary, Ministry of Industry & Commerce, Resettlement of Protracted Displaced Persons, Co- Operative Development and Vocational Training & Skills Development now invites sealed bids from eligible and qualified bidders for “**Construction of Canal Development Project at Industrial Estate at Ratmalana, Contract No.MIC/PR/04/03/09**” as described below and estimated cost of the project, approximately **Rupees Forty-Seven Million (Rs. 47 Million)** excluding contingencies and taxes. Contract Period is **120 Days and 365 days of defects liability period.**

The work consists of Removing existing brick, rubble and concrete structures and mud layer, construction of RCC drain, culvert and catch pit etc.

2. Bidding will be conducted through National Competitive Bidding Procedure.
3. To be eligible for contract award, the successful bidder shall not have been blacklisted and shall be registered with the Institution for Construction Industry Development Authority (CIDA) for Grade **C5 and C4 for Storm Water disposal and Land Drainage.**
4. Qualification requirements to qualify for contract award include:
  - (a) Average annual volume of construction work performed in last five years shall be at least **Rs. 71 Million.**
  - (b) The **minimum** amount of liquid assets and/or credit facilities, after setting apart for the other contractual commitments and exclusive of any advance payments which may be made under the Contract, shall be not less than **Rs. 8 Million.**
  - (c) Successful completion of one similar project costing not less than LKR thirty-eight Million (**Rs. 38 M**) excluding VAT completed within allocated time period as the main contractor during last five years.

Bids will be opened soon after closing in the presence of the bidders’ representatives who choose to attend.
8. Bids shall be valid up to 29/01/2020 (91 days from closing Date of the Bid)

All Bids shall be accompanied by a Bid Security (unconditional guarantee) of **Rupees five hundred thousand Only (Rs. 500,000.00)** issued by any commercial bank operating in Sri Lanka approved by Central Bank of Sri Lanka in the format given in Section 11 of Bidding Document. Bid security shall be valid up to **119 Days** from closing Date of the Bid. Bid Security validity period from **29/10/2019 to 25/02/2020** in favour of **Secretary, Ministry of Industry & Commerce, Resettlement of Protracted Displaced Persons, Co-Operative Development and Vocational Training & Skills Development,**
