The above construction Work is described in the Drawings & BOQ. The Architectural Design, Structural Design and specifications have already been completed by Consultant of Urban Development Authority for implement the project.

The construction period is **270 Calendar days** from the date of award of the contract.

2. Bidding will be conducted through **National Competitive Bidding Procedure (NCB).**
3. To be eligible for contract award, the successful Bidder shall not have been blacklisted and shall meet the following requirements
  - **Business Registration**
  - **ICTAD/CIDA Registration**
  - Grade : **C3 or above**
  - Specialty : **Building**
  - Experience : **At least two projects similar nature such as Construction Buildings for the past 5 years and the contract value for at least one project (should be completed project) shall be greater than Rs. 100 Mn.**
  - Others:
    - I. **Bidders should be registered under the Government Public Contracts Act, No 03 of 1987 which is applicable for every public contractors over five million.**
    - II. **VAT registration certificate should be attached with the bid. If not, VAT registered, Direction Letter issued by the Department of Inland Revenue should be attached.**
