

INVITATION FOR BIDS



CONSTRUCTION OF SLIPWAY AT BERUWALA

1. The Chairman, Ministry Procurement Committee - I, Ministry of Industry and Entrepreneurship Development, on behalf of the Secretary, Industry and Entrepreneurship Development invites sealed bids from eligible and qualified bidders for the **CONSTRUCTION OF BOAT LAUNCHING RAMP AT BERUWALA (Contract No. MI/FIN/30/50/1)**
2. Bidding will be conducted through National Competitive Bidding Procedure (NCB).
3. To be eligible for the Contract award,
The Bidder shall meet the **CIDA (previously known as ICTAD) Registration Grade C5 or above Contractor** specialized in Maritime Construction.
4. Pre Bid meeting followed by a site visit will be held at **10.30 hrs on 14.02.2025** at **Urban Council, Beruwala**
5. Bidding Documents will be issued between **9.30hrs to 14.30hrs** on working days from **03.02.2025** till **14.30 hrs** of **24.02.2025** (both days inclusive) by **Procurement Division of Ministry of Industry and Entrepreneurship Development** on a payment of non-refundable tender fee of **Rs. 12,500/=** Bidding Documents may be inspected free of charge at the same office and relevant websites.
6. All bids shall be accompanied by a Bid Security which shall be in the form included in section 8 in the bidding document in the favor of secretary of Ministry of Industry and Entrepreneurship Development an amount of **Rs. 500,000/= valid for a period of 120 days from the bid closing date (25.02.2025) and valid up to 24.06.2025** Bid Security shall be issued by a Bank and acceptable to Employer using the specimen form for bid security (unconditional guarantee)
7. The bid, in two copies duly completed with the prescribed bidding forms and required documents enclosed in two envelopes separately and marked as “ORIGINAL” and “DUPLICATE” and then , put the same into a suitable another envelope and sealed & marked “CONSTRUCTION OF BOAT LAUNCHING RAMP AT BERUWALA (Contract No. MI/FIN/30/50/1)” on the top left hand of the envelope, should either be forwarded under registered post to the Chairman , Ministry Procurement Committee – I , Ministry of Industry and Entrepreneurship Development , 73/1 , Galle Road , Colombo 03 to receive **not later than 14.00 hrs on 25/02/2025 or deposited in the tender box available at the Procurement division of the Ministry of Industry and Entrepreneurship Development,73/1,Galle Road,Colombo 03**. Late bids will be rejected.
8. Bids will be opened immediately after closing of the Bids. Bidders or their authorized representatives are requested to be present at the opening of the tender.
