Government Concessions for International Standard Certifications - 2025 ISO 9001, ISO 14001, ISO 22000, ISO 50001

The Ministry of Industry and Entrepreneurship Development has planned to implement this programme with the objective of providing special support to face the competitiveness within the export market for local products by improving quality management, upgrading of environmental management, enhancing energy efficiency and food safety for increasing the productivity of local industries. Accordingly, small and medium industries of the following sectors having an annual turnover of less than Rs. 01 billion and having a workforce of below 200 employees as at 01st January 2025 can apply to obtain benefits under the above programme.

Benefits :

- Certification fee up to a maximum of Rs. 200,000/- will be reimbursed for selected industries after submission of certificates and bills.
- If consultancy services are obtained from a government affiliated reputed institution or from a consultancy institution that is updated in the website of the Ministry, a consultancy service fee up to a maximum of Rs. 100,000/- will be reimbursed.

Eligibility :

- Should have maintained as a manufacturing industry within at least the 03 preceding years. (Production reports / records should be submitted)
- At the time of applying, the industry should be functioning properly.
- It is mandatory that the industry has not applied to any Certification and Consultancy Institution for obtaining certificates as at the date of publication of this newspaper advertisement.
- Priority will be given to industries that have not received any benefits in previous years under above mentioned Certification Programme.

Process of Selection :

- Selections will be made based on the conditions mentioned in the newspaper advertisement and facts ascertained at the interview.

Other Conditions :

- Certificate should be obtained from a Certification Institute accredited under the Sri Lanka Accreditation Board (SLAB).
- Selected applicants should enter into a Memorandum of Understanding (MOU) with the Ministry that the certification process will be completed before the scheduled date.
- The obtained Standards Certificate should be continuously updated for three (03) years.
- Should submit the Certificates and Bills to the Ministry on or before 31st October 2025 for the reimbursement of the Certification and Consultancy Fees.
- Should be a local industry and the local partner should own at least 60% of the company.
- Relevant industry should not obtain any similar benefits from any other government institution during the period the certification process is being implemented.

Applying :

Application perfected either via QR Code or Google Link should be submitted on or before 25th April 2025.
